Clinical Evaluation S2 Level

Clinical Expectations:

Students in their last semester of nursing school are expected to appropriately appraise and prioritize care for their patient(s). Students at the S2 level should consistently perform timely and accurate assessments independently. This includes using equipment with minimal to no assistance from clinical faculty, peers, or staff nurses.

S2 students should be knowledgeable regarding patient norms and be able to identify variations from these norms. If a patient problem/issue is identified, students should demonstrate good clinical judgement by utilizing critical thinking skills such as interpretation, analysis, and inference. As an S2, they should be able to identify and interpret relationships between their findings and begin to evaluate all aspects of the patient situation. Based on their analysis of the patient situation, students should be able to plan and implement evidence based intervention(s) and communicate these using professional communication tools (SBAR, etc.) to the instructor and possibly directly to the provider. Based on their knowledge and clinical experience at this level, second semester seniors should be inquisitive and question any aspect of their patient's care that they do not understand.

Students must consistently demonstrate their ability to provide safe patient care and to move through the nursing process from assessment to evaluation within a reasonable time frame with few, if any, verbal cues or assistance from the clinical faculty, peers, or staff nurses.
